Dear Family of a EBR Acceleration Academy Student:

The East Baton Rouge Parish School System (EBRPSS) has received new information from the Louisiana Department of Education about the performance of EBR Acceleration Academy during the 2008-2009 school year.

**1. Why was EBR Acceleration Academy identified as a “school in need of improvement,” and how does it compare to other schools in East Baton Rouge Parish and in the rest of Louisiana?**

EBR Acceleration Academy was identified as a school in need of improvement because it failed to meet performance goals established by the state in the areas of standardized tests, attendance and dropout rates. The school received a 2009 School Performance Score (SPS) of 28.1 that placed it in the category of an Academically Unacceptable School (AUS 1).

The Louisiana Department of Education maintains the accountability information for all schools in East Baton Rouge Parish and the state of Louisiana. **2. What is EBR Acceleration Academy doing to address the problem of low achievement, and what is the School System and the state doing to help them address the problem?**

The administration is evaluating all areas of instruction aggressively at EBR Acceleration Academy. This evaluation includes interviews and surveys of students, teachers and parents to determine what areas need to be improved. The survey information will be used to prepare a proactive School Improvement Plan. This plan requires classroom instruction and teacher training that focuses on improving the areas in which students at EBR Acceleration Academy are having difficulty. In the meantime, the school is exploring tutoring, mentoring and other types of assistance to improve student achievement.

**3. How can I become involved in addressing the problems that caused EBR Acceleration Academy to be identified as a school in need of improvement?**

Parents are encouraged to arrange a private conference with their child's teachers to discuss ways to improve his or her academic performance. They also are invited to become members of the School Improvement Team at EBR Acceleration Academy. The School Improvement Team is composed of the principal, teachers and parents and works to improve the education and overall learning experience of all students at EBR Acceleration Academy. Even if a family member does not serve as a member of the School Improvement Team, he or she is encouraged to attend meetings to discuss possible improvements in any area of instruction.

**4. Is my child eligible for School Choice?**

Because EBR Acceleration Academy is a school attended by parental choice, you always have the option for your child to return to his or her home school.

## 5. Is my child eligible for free tutoring (Supplemental Educational Services)?

Students at EBR Acceleration Academy may be eligible to receive extra academic assistance through a program known as **Supplemental Educational Services (SES)**. These services are offered free of charge and are intended to help your child improve his or her academic performance.
